

# **Chair's Report**

If I had to look back over the last year, and then look forward to the year that we are already in, I would say that we are in critical times.

Victorians with disability are rightly concerned about whether the disability advocacy sector has sufficient capacity to provide them with the support required to ensure their human rights are respected.

The disability advocacy sector has been whittled away in the last year, making it more difficult for us to provide the high level of service that is required. This erosion of disability advocacy has been happening in conjunction with other significant and unwelcome changes.

The NDIS Act changes have not been led by people with disabilities, and there is great disquiet in the community about their implications.

The underwhelming take-up of the Disability Royal Commission recommendations has also been quite a blow. How does the community respond psychologically to the implicit message from governments about the low importance of the human rights of the disability community? How do we respond literally - how do we prioritise, when so few recommendations were fully accepted out of over 200?

Then there was the announcement of the Victorian Government's intention earlier this year to close all disability specific regulators and subsume them into the new Social Services Regulator.

This decision was in direct contravention of the state government's pledge in the State Disability Plan of "nothing about us without us" leading their decision-making. It was also in contravention of the Disability Royal Commission Recommendation 11.3.

Disability Advocacy Victoria clearly sets out in its 2024 Strategic Plan that the leadership of disability policy and regulation of disability services must be by people with disabilities. This is a basic principle in disability advocacy. A number of members of Disability Advocacy Victoria are disability led advocacy agencies, and we were pleased to work with them and the rest of the disability advocacy sector in lobbying the State Government to change its decisions. The plan for the Disability Services Commission to be the first cab off the rank to close and be absorbed into the Social Services Regulator at the last minute did not go ahead after sustained lobbying from the sector and a number of allies/Members of Parliament.

The expectation that people with disability must be involved at the very start of the process of decision-making must become the norm for our government.

We were very excited to see mid-2024, the establishment of DPO Victoria, a collective of Victorian disability led organisations. It is vital that people with disabilities have a voice at all tables, and the government have a point of contact to start genuinely collaborating with the Victorian disability community. We look forward to working with them.

While technically always being outside of the last financial year, it's important to mention the DARU/DAV/VCOSS Strengthening Advocacy Conference which again provided a focal point for people with disabilities and the advocacy sector to come together and discuss important issues affecting us.

We look forward to continuing our support of the disability advocacy sector through DARU.

It is more important than ever that our sector stands strongly united in such testing times. There is a lot of work to do in the next year to reverse some of the thinking and actions of government that have impacted strongly and negatively on our community.

We look forward to standing beside you and doing this work.

# **Treasurer's Report**

I am pleased to present the Treasurer's report for Disability Advocacy Victoria for the financial year ending June 2024. Our financial statements have been audited once again by Barco and Associates to ensure transparency and accuracy in our financial reporting.

### **Financial Performance**

This year, I am pleased to report on another year of strong financial performance for our organization. We have achieved a healthy surplus of \$8,648, a slight decline from the surplus of \$10,179 in the previous year. This positive financial outcome has resulted in a relatively strong balance sheet for a small organisation with no direct employees, with net equity of \$104,147.

#### Cash at Bank

Our accumulated surpluses are entirely in the form of cash at bank, providing us with the means to meet our financial obligations promptly and enabling us to rapidly and simply deploy resources to support a part-time limited term project coordinator position as a key new strategic initiative in the new financial year.

#### **Future directions**

In conclusion, the financial health of Disability Advocacy Victoria remains robust as at the end of June 2024, giving DAV the capacity to invest in developing our role as the peak body for a sector under significant pressure, and enabling us to waive membership fees from the disability advocacy organisation members currently running deficits and retrenching staff. As we undertake investment and build our role, our financial base is likely to come under pressure, however, so we will need to carefully manage resources in the coming year.

I would like to express my gratitude to our members and committee members for their strong support and solidarity, which has contributed to our continued success.

# **Report on the Audit of the Financial Report**

# Opinion

We have audited the financial report of DISABILITY ADVOCACY VICTORIA INC (the association), which comprises the Statement by Members of the Committee, the Income and Expenditure Statement, Balance Sheet as at 30 June 2024, a summary of significant accounting policies and the certification by members of the committee on the annual statements giving a true and fair view of the financial position and performance of the association.

In our opinion, the accompanying financial report presents fairly, in all material respects, the financial position of the association as at 30 June 2024 and [of] its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements and the requirements of the Associations Incorporation Reform Act 2012.

## **Basis for Opinion**

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the association in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

# Emphasis of Matter – Basis of Accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to assist the association to meet the requirements of Associations Incorporation Reform Act 2012. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

## **Responsibilities of the Committee for the Financial Report**

The committee is responsible for the preparation and fair presentation of the financial report in accordance with the financial reporting requirements of the Associations Incorporation Reform Act 2012 and for such internal control as the committee determines is necessary to enable the preparation and fair presentation of a financial report that is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the committee is responsible for assessing the association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the committee either intends to liquidate the association or to cease operations, or has no realistic alternative but to do so.

#### Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the association's internal control.

- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the committee.

- Conclude on the appropriateness of the committee's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the association's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the association to cease to continue as a going concern.

- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
